RECOMENDATION FOR \$85,000 IN BUDGET AMENDMENTS TO PROVIDE

FOR TRAINING FOR MERA SYSTEM USERS (\$60,000) AND FOR

TECHNOLOGICAL SERVICES (\$25,000)

<u>Recommended Action</u>: Approval of amendments to the 2007-08 budget to provide for training for MERA system users and for technological services, as recommended by the Executive Committee

SUMMARY:

1. Training

MERA budgeted \$60,000 for this essential training during FY 2006-07 but was unable to initiate training due to delays in perfecting the contract. As a result, only \$120 was spent and few member agency staff were trained. The current budget has \$45,000 for this training but as we wish to accelerate training, most of those funds have been spent (see Attachment A for some workload measures.) Staff now recommends that the budget savings from last year be reappropriated, via a transfer of funds from the MERA Fund Balance, to allow a return to the original schedule. The expenditure over the two-year period will be as planned.

1. Technical Services. The County Department of Public Works provides a variety of technological services, under contract, through the management of consultants to advise on specialized technical matters, or to conduct studies for which County staff is not available. The demand for these services have exceeded expectations, again largely through a lack of activity during 2006-07, and there are insufficient funds to complete the work anticipated for the balance of this year.

The areas where activity is planned are:

- Motorola Services;
- CitCom Dictaphone Consulting Service Review of proposals are due at the end of November, coordinating with affected agencies, recommend purchasing equipment as appropriate;
- DELTAWRX Consulting Continue evaluation of existing Motorola contract, evaluation of coverage problem areas and recommendation of specific solutions for each area, and, assist with negotiations and dealing with station printing issues; and,
- The creation of the MERA/Motorola Repair Bank Pre-funding, at a sharp discount, the replacement of worn and broken parts. The mountain top facilities are owned by MERA. Previously, parts were repaired or replaced one at a time with no scale of economy in place. By pre-purchasing \$18,000 worth of Repair Bank dollars, we will receive \$24,000 of parts and services, thus a savings of \$6,000.
- 1. Fiscal Year 07-08 Technical Services Budget

We are anticipating that with many technical issues still pending, additional funds <u>might</u> be needed, at an estimated \$25,000 for the remainder of fiscal year. Obviously, unspent funds are not billed. County DPW spends the funds first, and then seeks reimbursement.
