## **MERA Executive Committee System Operations Update**

December 10, 2008

- 1. Mobile and portable code plug revisions
  - a. SO Admin and Investigations are essentially completed with a few radios yet to be found.
  - b. SO Jail and Courts scheduled for week of December 8<sup>th</sup>.
- 2. Delta-Wrks has submitted their cost estimates for system coverage updates.
- 3. Priority upgrade of 50 County DPW critical radios has been completed.
- 4. Jail talkgroup has been designated as "East" system only to reduce loading on the West Marin system. The East system has the most capacity and the least number of busies. Jail operations have not been impacted.
- 5. Alternatives intended to reduce system loading are being reviewed.
- 6. Remote sites are being inspected and generator fuel levels topped off in preparation for the upcoming storm season.
- 7. System parameters are being reviewed in anticipation of the upcoming San Rafael Fire dispatch move to County Communications dispatch center.
- 8. County fire has conducted preliminary testing on their use of the VHF overlay.
- 9. System data bases are being updated to reflect latest alias and programming changes.
- 10. System maintenance activity
  - a. Weekly, monthly and quarterly system checks have been completed.
  - b. Quantar PA amplifier at Mt. Tam was replaced and sent to factory for repair.
  - c. Main and backup power supplies in zone controller replaced and sent to factory for scheduled battery replacement.
  - d. Reviewed processor run time issues for backup Firescad server.
  - e. Replaced dispatch Firescad radio at Station 14 received from factory for repair.
  - f. Replaced rectifier at San Pedro and sent to factory for repair.
  - g. Replaced Efratom display module at San Pedro.
