## 2010 ANNUAL PROGRESS REPORT ON AUTHORITY OPERATIONS AND ACTIVITIES

In accordance with Section 8.4 of the Marin Emergency Radio Authority Joint Powers Agreement, this annual report summarizes for the member agencies significant Authority operations and activities undertaken in 2010. Within available resources and without additional member agency augmentation, important system operating and administrative enhancements have been completed or are underway.

- 1) Adoption of Resolution Approving Restated Project Operating Agreement, Indenture of Trust, Official Statement, Purchase Contract, Continuing Disclosure Agreement and Directing Other Actions for the Refinancing of MERA 1999 Revenue Bonds, resulting in member agency savings.
- 2) Approval of Investment of 2010 Revenue Bonds Reserve with Federal National Mortgage Association.
- 3) Approval of Change Order No. 1 for MERA Frequency Expansion Project, including \$170,000 savings for equipment and services.
- 4) Completion of installation of five additional frequencies by Motorola.
- 5) Continued planning and entitlement analyses of Tomales Site Coverage project (allocation of \$600,000) and development of draft site lease.
- 6) Continued exploration of Martha Property to improve system coverage.
- 7) Approval of new five-year Emergency Communications System Maintenance Agreement with County of Marin.
- 8) Approval of new three-year Communications Engineering Services Agreement with County of Marin.
- 9) Completion of CTA Study of Interoperability Options for Marin County funded by UASI.
- 10) County Department of Public Works representation of MERA and all agencies within the County on work groups, projects and associations working on regional partnerships, public safety projects in the Bay Area and grant initiatives to fund studies, training and equipment.
