SUBJECT: AGENDA ITEM <u>E</u>: PROPOSED PRELIMINARY FY13-14 MERA OPERATING, NEW PROJECT FINANCING AND REVENUE BONDS BUDGETS

<u>Recommended Action</u>: Review and recommend the Proposed Preliminary MERA FY 13-14 Budgets to the Executive Board for Operating, New Project Financing and Refunding Revenue Bonds.

<u>Background</u>: Total Proposed Preliminary Operating Budget for FY13-14 is \$1,641,642, which represents a 3.1% increase over prior year's budget. A recent history of total annual operating budgets and percentage changes over prior years is as follows:

The second budget is for the 2007 Citizen Bank Loan Note for supplemental capital borrowing. The Governing Board directed that this payment remain the same through the life of the Note.

The third budget is the annual debt service for the Refunding Revenue Bonds and there is no discretion in the payment amount.

Member agency contribution schedules, based on the Executive Board's approval of the Preliminary Operating Budget, will be distributed to the members on or about March 14.
