SUBJECT: AGENDA ITEM C-3: Federal Engineering Contract Update

Recommended Action: Accept the Report

Federal Engineering's (FE) Phase 2 contract started in March of 2017. The Phase 1 contract included preparation of the request for proposals that led to the Motorola contract and Phase 2 includes services to oversee the design and implementation (not including construction oversight) of the Next Gen system. In general, FE acts as a day to day manager of the Motorola Contract and are in regular contact with both Motorola and County staff. The primary functions of FE staff have been to coordinate project meetings, review and monitor the Motorola project action log, maintain a punch list of Motorola implementation activities, and prepare correspondence and review of project submittals up to the current level approaching 75%. FE staff also participates in weekly conference calls with County staff and FE senior management, as well as participation on the bi-weekly MERA call regarding the project status. FE has been very active in assisting County staff with CEQA related tasks and lease document support.

FE's Phase 2 contract includes six main tasks and had an assumed duration of two and one-half years from inception, that results in FE's Phase 2 contract expiring in the end of July 2019. The tasks are: 1) Implementation Project Management; 2) Preliminary Design Review and Final Design Review; 3) Factory Testing, Equipment Delivery, and Installation Verification; 4) Coverage and System Testing; 5) System Acceptance and Cutover; and 6) Documentation. Task 1 is ongoing, and Task 2 is anticipated to be complete upon the acceptance of the final system design which will occur following CEQA approval. The following is a summary of FE's expenditures through November and remaining contract balance.

County Staff has been working with FE for the past several months to amend their contract such that it aligns with the overall project schedule. This may result in additional costs as the assumed duration is no longer valid and FE has performed work on the Next Gen project that is not in their current Phase 2 scope. County Staff has identified several areas where FE can support the County's obligations under the Next Gen Implementation Agreement to assist with project delivery. Examples include, but are not limited to assistance with lease document preparation, construction document preparation, and permitting for sites. Tasks performed by FE towards this effort will be billed against the Next Gen Implementation budget and not against the overall Next Gen Project budget. A contract amendment will be brought before your Board for approval detailing these items in the next few months.
