SUBJECT: AGENDA ITEM D: Operations Working Group Attendance

Recommended Action: Accept the report.

The purpose of the Operations Working Group is to advise on and evaluate the performance of the current MERA communication system, as well as give input on the Next Gen System implementation. Monthly meetings have been held over the past year with attendance from various member agencies (attendee list attached for past eight months). The agendas for the meetings routinely include analysis of radio requests from both member and non-member agencies, updates on the Next Gen project, updates to the CEQA process, and discussion of the system usage statistical reports. In the recent past, the group has given input on the following topics: Next Gen Contract Change Orders #1 thru #11, Radio Alias Model for Next Gen, Knobology, First Gen System Radio Surplus Policy, and updates to the Mutual Aid and VHF Overlay Plans.

Moving forward and in addition to the recurring monthly items, the Operations Working Group will be asked to provide input on several topics that affect member agencies including, but not limited to: finalizing fleet mapping, agency cutover planning, Fire Station Alerting installation and cutover tasks, and early radio installation planning. In addition to these, there will be many other items that have the potential to impact MERA member agencies as we transition the old system to the Next Gen System. With the close of CEQA anticipated for Fall 2019 and the completion of the Next Gen System design shortly following, careful planning for these various activities is needed and the Operations Working Group is best suited to advise on behalf of MERA member agencies. With good coordination and participation from the member agencies, we can ensure a smooth and timely transition to the Next Gen system.
