During Call #2, the County posed a new option for MERA's consideration for Project Construction Services, which resulted in follow-up calls with the MERA Team and AECOM, as a potential provider of Project Construction Services. This option proposes that MERA contract with the County to complete all the remaining site permitting, entitlements, construction drawings review/stamping, construction bid packages for NGP sites, bidding and award administration and construction management through the end of the Next Gen Project.

MERA Representatives are assessing Project Management organizational, staffing/service delivery options for recommendation to the Governing Board, along with actions on the following matters before June 30, 2020:

- 1) assignment and assumption of County NGP Agreements to MERA (Motorola and Other Contractors),
- 2) engagement of Program Manager and Construction Management and Implementation Coordination Services.
