B. Executive Officer's Report

1. Receive Report #110 on the Next Gen System (Plamondon – Report)

Heather Plamondon gave the Next Gen System Report, as included in the packet, on behalf of Dave Jeffries. She notes that there are few changes to the project schedule, and that the team is working diligently with Fidato to proceed with construction in earnest. She continues going over the packet touching on various items including code plugs, pilot equipment/sites, upcoming end-user training, a new project manager with Motorola, fire station alerting, and the Motorola radio testing site. Plamondon fielded a question from the Board regarding the purchase and ordering of electrical panels, noting that the supply chain delays have been mitigated through early ordering.

2. Review and Approve Motorola Change Order #19 (Jeffries – Action)

Heather Plamondon reviewed item B2 on behalf of Dave Jeffries. She explained that it is a nocost change order to officially document the change in the Motorola project manager. No questions or comments.

3. Election of Officers for MERA Governing Board, President and Vice President (Plamondon – Action)

Plamondon reviewed Item B3, explaining that the recommended action for the Board is to either reelect the sitting officers Pearce and Cusimano, or to nominate other candidates for election. Plamondon noted that the sitting leadership expressed a willingness to continue serving for another year, and that no others came forward with nominations.

4. Review and Approve Motorola Change Order #18, Construction Design (Plamondon – Action)

Heather Plamondon explained item B4 as an approval of Motorola Solutions' revisions of drawings to due in-field adjustments that have been required as of beginning construction on a number of sites. The total value of the change order is \$23,047.06, bringing the contract total with Motorola to \$46,446,713.79.

5. Adopt Resolution Approving FY23-24 Operating and Project Budgets (Plamondon – Action)

Heather Plamondon reviewed item B5, explaining that the Operating and Project Budgets were presented and reviewed during prior Governing Board meetings, and are now proposed to be officially approved and adopted. She confirmed that there have been no changes since the Board last saw the documents.

 - 1. Receive MERA System Operations Update March/April (Williams Discussion)
 Todd Williams presented the Gen 1 system operations update, noting that the system is performing well overall. He described minor system outages and concerns that, once addressed, prompted his team to replace a number of parts across various sites, leading to even better performance than usual. He concluded the report with system analytics, reaffirming that the system is performing well and should continue to do so until the Next Gen system comes online.
 - 2. Review and Approve Request to Add One Radio for DPW Transportation (Williams Action) Williams reviews a request from DPW Transportation for an addition of a single radio to their existing network.
