 - Fielded questions regarding transfers and availability of funds.
 - Committee notes:
 - FY 23-24 Measure A revenue should be \$3,540,000 due to reduction in the parcel tax.
 - Discrepancy between budgeted capital outlay shown and cash flows for fund 38.
 - Need improved clarity in the balance sheet fund names as numbers can be confusing.
 - Reviewed FY 22-23 revenues and expenditures

- Committee needs clarity on accounting of US Bank assets Available Capital Funds US Bank 1081-1082.
