B. Executive Officer's Report

- 1. Receive Report #117 on the Next Gen System (Jeffries Report)
 Dave Jeffries gave his report to the board as included in the packet. He reviewed the status of Next Gen project sites, noting construction progress/delays, as well as the continued progress of Motorola/Microwave installation. Jeffries reviewed the Key Project Summary Details, including Code Plugs, Connectivity, the Microwave Network, End User Training, Technician Training, FCC Licenses, and the Cutover Plan. Concluded by reviewing the Project Summary Table and taking questions from the board.
- 2. Item Pulled for Further Staff Review
- 3. Review and Approve Motorola Change Order #25-Gen One Site Electric Updates (Plamondon-Action)

Heather Plamondon reviewed Item B3, explaining the change order and referencing a document to show how the funds would be reallocated from fund 32 to respond to the Gen 1 expense.

4. Review and Approve Second Amendment to Marin Municipal Water District Lease-Forbes Hill Reservoir (Plamondon-Action)

Heather Plamondon reviewed Item B4, explaining that it is a 1-year extension for the no-cost lease on the Gen 1 site with Marin Municipal Water District.

5. Review and Approve Renewal of NBS Service Agreement for Measure A (Plamondon-Action)

Heather Plamondon reviewed Item B5, describing the services that NBS provides for MERA and the history of the agreements made for said services. Explains that NBS has offered a new agreement with an updated/expanded scope of work, as well as an increase in cost. Plamondon fielded questions from the board regarding details of the agreement and potential alternative options. The board discussed options at length and agreed that it would be worthwhile to communicate with NBS about options for the agreement, as well as explore/research more about what they are offering and potential alternatives. Item B5 tabled for later meeting.

6. Receive Update from Executive Officer re: Sperry Capital Efforts (Plamondon-Receive Report)

Heather Plamondon reviewed the efforts with Sperry Capital noted in Item B6. MERA has put out the RFP for the municipal bond and received proposals from 2 agencies. After consulting with the Sperry Capital team, the Finance Committee concluded that Oppenheimer & Co. Inc. would be the most suitable option, provided that MERA could meet the debt service requirements. Documents are being reviewed in order to proceed with the bond issuing, allowing for projected access to funds in May 2024.

- C. Operations Reports (Williams)
 - 1. Receive MERA System Operations Update January (Plamondon Discussion)

Todd Williams reported on the operations of the Gen 1 system, notes good performance overall. Notes several part replacements as well as system glitches that were resolved by the team – the latter in part due to the training and assistance from Motorola. Notes no major concerns but looking forward to the Next Gen System.

D. Open Time for Items Not on Agenda – None

Heather Plamondon notes that she traveled to California and visited several project sites. She applauds the work and progress of both the Gen 1 and Next Gen Project teams.
